If an item has no author, start the citation with the article title. When an article has one to seven authors, all authors' names are cited in the References List entry. When an article has eight or more authors list the first six authors followed by three spaced ellipse points (...), and then the last author's name.

The sixth edition provides explicit rules for direct quotations and states that you must credit the source when "paraphrasing, quoting an author directly, or describing an idea that influenced your work" (p. 170). If the quotation is less than 40 words, incorporate the quotation into the text and place quotation marks round the quotation.

Note: All citations should be double spaced and have a hanging indent in a Reference List. A "hanging indent" means that each subsequent line after the first line of your citation should be indented by 0.5 inches. Below is a link to an APA sample paper that contains instructions about how to format a hanging indent in a paper.

### Websites - APA Style (6th Edition) Citation Guide ...

For 2 authors in an APA citation of journal, first give the information for the first author followed by a comma, then use an ampersand (&) and list the information for the second author. For 3 to 20 authors, separate the author names with commas and again use an ampersand (&) before the final author name.

APA style dictates that brackets should directly surround their content without spaces (e.g., [bracketed content] should look like this).
