Stormwater discharges from FDOT projects and facilities are regulated under multiple water pollution control programs, including the National Pollutant Discharge Elimination System (NPDES) stormwater permitting program. FDOT operates both Phase I and Phase II Municipal Separate Storm Sewer Systems (MS4s) throughout the state and is regulated by NPDES MS4 permits issued by the Florida Department of Environmental Protection (FDEP) and approved by the US EPA.
